WHEREAS. The Clean Air Company of Fords, New Jersey provided the sole bid in the amount of \$46,765.14 and;

WHEREAS. The submitted bid complied with the bid specifications, with no exceptions.

NOW THEREFORE it is herein Resolved by the Board of Fire Commissioners, Fire District #2 to award the contract for the installation of a Direct Capture Diesel Exhaust Removal System to Clean Air Company of Fords, New Jersey in the amount of \$46,765.14.


