3. Fire District Election:

- a. I'm pleased to report that incumbent Commissioners Reichert and Donahue were reelected to three-year terms, and the budget passed with 503 Yes and 176 No votes. The listed results have been reported to township and state officials as required.
- b. As approved by the Board, a letter has been forwarded to the Chairperson of the Camden County Board of Elections to request assistance with reducing our annual election costs, which have increased 142% since 2017.
- 4. I'm currently working with FEMA and NJ OEM representatives on a grant application for overtime and material costs related to the Covid pandemic. I'm hoping to have the application completed and submitted by the end of next week.
- 5. Security Lock and CCTV of Blackwood, NJ has installed the card reader and control panel for the front lobby door project. Thanks to Captain Procopio for installing the electrical receptacle needed to power the panel. Associated Building Specialties is awaiting delivery of the slabs for the new doors, and are hoping to have them in the near future.
