

The proposed 2022 Annual Budget calls for appropriations in the amount of \$2,104,615, appropriations for the 2021 Adopted Annual Budget were \$2,177,965, this is a decrease of \$73,349. The main reason for the decrease is that two Firefighters retired in late 2021 and are being replaced with two new Firefighters at a reduced salary.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain reason for the increase/decrease in the budgeted line item.

Unrestricted Funds Balance has decreased to \$20,799 in the proposed 2022 Annual Budget. This is a decrease of \$275,559 or 93.0% from the 2021 Adopted Budget. The District is utilizing Levy Cap Bank Funds from 2019-2021 to fund the difference in Appropriations and Anticipated Revenues for the 2022 Budget. The District is also going to use the maximum allowable amount to be raised by taxation for the 2022 Budget.

Interest on Investments has decreased to \$1,200 in the proposed 2022 Annual Budget. This is a decrease of \$800 or 40.0% from the 2021 Adopted Budget. This decrease is a result of reduced interest rates currently being offered by the District’s bank.

Operating Grant Revenue-SAFER Grant has decreased to \$1,201 in the proposed 2022 Annual Budget. This is a decrease of \$35,552 or 96.7%. 2022 will be the last year FEMA reimbursement assistance under the current program that is for reimbursement of Firefighter salary and benefits.

Other Revenue #1 BMOC share has decreased to \$0 in the proposed 2022 Annual Budget. This is an decrease of \$10,000 or 100.0%. The decrease is due to the cessation of shared building maintenance reimbursement.

Other Offset Revenues #1-Gloucester Township FD 3 Shared Services has increased to \$18,000 in the proposed 2022 Annual Budget. This is a increase of \$18,000 or 100%. Other Expense #2-Gloucester Township FD 3 Shared Services has increased to \$18,000 in the proposed 2022 Annual Budget. This is an increase of \$18,000 or 100%. CTED 2 entered into an agreement with

The amount to be raised from taxation for the proposed 2022 Annual Budget is \$1,999,542, the amount is 13.1% higher than the 2021 Adopted Budget. The District is going to utilize the maximum allowable amount to be raised by taxation for the 2022 Budget. The District is also going to utilize funds from the 2019 Levy Cap Bank, 2020 Levy Cap Bank, 2021 Levy Cap Bank and Unrestricted Funds of \$20,799 to balance Revenue and Appropriations for the 2022 Budget. \$296,358 of the unrestricted fund balance was used in the 2021 Adopted Budget.
