N.J.S.A. 40A:11-12 - STATE CONTRACT

WHEREAS, N.J.S.A. 40A:11-12, of the laws of the State of New Jersey permits a contract for purchase to be awarded without prior advertising when said purchase is pursuant to an existing State Contract for supplies, materials or equipment provided that a State Contract number is provided and available for the material, supplies or equipment to be purchased, and

WHEREAS, The Board of Fire Commissioners has determined that it is in the best interest of the Fire District to award the purchase pursuant to the State Contract, and

NOW THEREFORE it is herein Resolved that a contract for the purchase of three (3) sets of PPE be and is hereby awarded to Continental Fire and Safety of Hamilton, NJ pursuant to State Contract Number 17-Fleet-00805 in the amount of \$12,504.00.


RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS FIRE DISTRICT #2


