

RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS
FIRE DISTRICT #2, TOWNSHIP OF GLOUCESTER
AUTHORIZING THE TRANSFER OF ONE 1998 SEAGRAVE FIRE APPARATUS
TO CARROLL TOWNSHIP VOLUNTEER FIRE DEPARTMENT AND AUTHORIZING THE
SIGNING OF A BILL OF SALE
FOR THE CONSIDERATION OF \$ 115,001.00

WHEREAS. The Board of Fire Commissioners Fire District #2, Township of Gloucester has determined the 1998 Seagrave FWD 95' Aerialscope Tower Ladder VIN# 1F9H838J8WCST2060, is of no use to the Fire District and should be removed from inventory, and

WHEREAS. The Fire District did advertise seeking sealed bids for the sale of the vehicle, and

WHEREAS. The Board of Fire Commissioners received one bid seeking to purchase the 1998 Seagrave FWD 95' Aerialscope Tower Ladder VIN# 1F9H838J8WCST2060, and at an open public meeting the Board has determined that bid was from a responsible bidder, meeting the bid qualifications.


NOW THEREFORE, It is herein RESOLVED the 1998 Seagrave FWD 95' Aerialscope Tower Ladder VIN# 1F9H838J8WCST2060 shall be removed from inventory and the Board of Fire Commissioners is hereby authorized to transfer title and sale of the vehicle to Carroll Township Volunteer Fire Department for the consideration price of \$115,001.00.

Be it Further Resolved that the Chairman and Secretary to the Board is hereby authorized to sign a Bill of Sale to Carroll Township Volunteer Fire Department transferring the vehicle in as-is condition, at time of delivery and without warranty or representation made as to its fitness for the use intended by the Buyer.

BE IT FURTHER RESOLVED, that as a part of the agreement to transfer title to Carroll Township Volunteer Fire Company, with the condition of Delivery and acceptance being at the Fire District office located at 43 Somerdale Road, The Board of Fire Commissioners did agree to financially assist with the transportation cost associated with the transport of the fire Apparatus to Monongahela, Pennsylvania in the amount of \$4,200.00. Said transportation cost to be paid as a credit against the purchase price in the amount of \$4,200.00. Accordingly, at time of delivery, Carroll Township Volunteer Fire Company shall deliver to the Fire District the sum of \$110,801.00.
