RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS, FIRE DISTRICT # 2,
OF THE TOWNSHIP OF GLOUCESTER, CAMDEN COUNTY NEW JERSEY
TO ADOPT A TEMPORARY BUDGET, PENDING PUBLIC APPROVAL OF THE
PROPOSED BUDGET.

WHEREAS, N.J.S.A. 40A:14-78.17 authorizes the adoption of a temporary budget not to exceed 14% of the total budget for the preceding fiscal year, and

WHEREAS, The 2023 Fire District Budget was \$3,064,792.86, 14% of which equals \$429,071.00.

NOW THEREFORE, it is herein Resolved that the Board of Fire Commissioners, Fire District #2, shall adopt a temporary budget of \$429,071.00, pending public approval of the proposed 2024 budget, scheduled for February 17, 2024.

RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS, FIRE DISTRICT # 2,
OF THE TOWNSHIP OF GLOUCESTER, CAMDEN COUNTY NEW JERSEY
TO AMEND THE PROPOSED 2024 FISCAL YEAR BUDGET PURSUANT TO
N.J.S.A. 40A:14-78.3

WHEREAS, the Fire District Budget for the Fiscal Year beginning on January 1, 2024 and ending on December 31, 2024 was introduced on December 13, 2023 and;

WHEREAS, a public hearing on the 2024 Fire District Budget is scheduled for January 10, 2024 as publicly advertised and;

WHEREAS, the budget review by the New Jersey Division of Local Government Services Board identified the need for amendments to certain line items in the Proposed 2024 budget.

NOW THEREFORE, it is herein Resolved and approved that the following amendments to the Introduced 2024 Fire District Budget be made:

Changed the Amount to be Raised by Taxation to Support Budget for the 2024 Proposed Budget from \$2,150,205.25 to \$2,294,606.92.

Removed \$144,401.67 from Capital Appropriations Offset with Restricted Fund. Total Capital Appropriations for 2024 is now \$100,000.

BE IT FURTHER RESOLVED that a copy of this Resolution will be filed forthwith with the Division of Local Government Services for the certification of the 2024 Fire District Budget as so amended.
